

Sub: Offer for Sale of Ferro Grade Ore along with SMGR (Mn-25%) for Ferro Alloys Manufacturers (having submerged arc Furnaces) only for the Quarter Jan-Mar 2026.

Dear Sir,

4. The equal quantity of 25% Mn is to be accepted against the allotted quantity of the Ferro grade. Buyer has to sign the contract for allotted quantity of Ferro grade along with the allotted quantity of SMGR(Mn-25%).
5. The prevailing price and discounts shall be applicable on the date of dispatch.
6. **MOIL reserves the right to revise the prices at any time** during the contract period.

 - a. In case, the allotment of 200 MT of BG4582 is made, then the buyer has to accept equivalent quantity of TDL499.
 - b. In case, the allotment of 200 MT of BG4583 is made, then the buyer has to accept equivalent quantity of TDL499.
 - c. In case, the allotment of 200 MT of DB2367 is made, then the buyer has to accept equivalent quantity of TDL499.
 - d. In case, the allotment of 200 MT of GM4516 is made, then the buyer has to accept equivalent quantity of GML464.
 - e. In case, the allotment of 200 MT of GM4552 is made, then the buyer has to accept equivalent quantity of GML464.
 - f. In case, the allotment of 200 MT of MS4525 is made, then the buyer has to accept equivalent quantity of GML464.
 - g. In case, the allotment of 200 MT of UK4571 is made, then the buyer has to accept equivalent quantity of SPL463.
