I. COMPANY PROFILE

MOIL Limited is Schedule "A" Miniratna Category-I Company. It was originally incorporated as Manganese ore (India) Limited in the year 1962. MOIL is mainly engaged in production and sale of manganese ore and has mines located in Maharashtra and Madhya Pradesh States. It has ten mines, seven of which are underground. It is the largest manganese ore producer in India. It also operates Electrolytic Manganese Dioxide (EMD) plant of 1,500 MTPA capacity. EMD is mainly used for production of dry battery cells and in pharma sector. It also operates a Ferro Manganese Plant of 12000 MTPA capacity.

MOIL is listed on National Stock Exchange and Bombay Stock Exchange. The present shareholders in the company are Govt. of India (53.35%), Govt. of Maharashtra (5.96%) and Govt. of Madhya Pradesh (5.38%). The balance of 35.31% shares is held by the public. The company employed 5250 regular employees (Executives: 336, Non-executives: 4914) as on March 31, 2025.

MOIL being India's largest manganese ore producer, accounts for about 50% of India's production. It has around 108 million MT of reserves and resources of manganese ore and has plans to enhance its production from current level of ~1.76 million MT to 3.00 million MT by 2030 from its existing mines as well as by venturing into other States to meet the country's growing needs of manganese ore.

The authorized and paid-up capital of the Company is Rs. 300 crores and Rs. 203.48 crores respectively as on 31.03.2025.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Production & Planning) is a member of the Board of Directors and reports to CMD. He/she is the Head of Production, Projects and Planning Departments of the organization. He/she is accountable for achieving high degree of performance and productivity through well directed

coordination of all operations.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and not in a contractual/ad-hoc capacity – in one of the followings:-

3. QUALIFICATION:

The applicant should be an Engineering graduate with good academic record from a recognized University/ Institution. Preference will be given to applicants with Engineering degree in Mining discipline.

Applicants with MBA/ PGDM qualifications will have an added advantage.

4. EXPERIENCE:

The applicant should possess technical/ operational experience/ exposure in a large organization of repute, out of which at least 5 years during last 10 years should have been in major mining/ production/ manufacturing units.

Experience in mining and related projects would have added advantage.

VI. UNDERTAKING BY THE APPLICANT

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- **4.** In the above cases, no request for relaxation or otherwise would be entertained.
