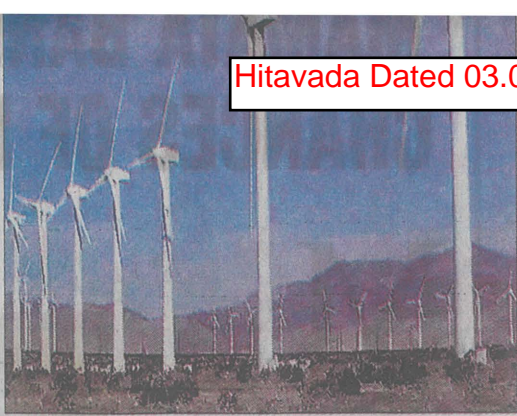

24 Central Vista project labourers injured in mishap

NEW DELHI, Aug 2 (PTI)

TWENTY-FOUR labourers got
injured on Tuesday after a private
bus carrying them to the Central
Vista project site collided with a clus-
ter bus in central Delhi's Patel Nagar,
police said.

They said four more people --
including the driver of the private
bus and three passengers of the clus-
ter bus -- were also injured.

Police said they received infor-
mation about the accident at 9 am.

Upon reaching the spot, police
said they found that the bus carry-
ing the labourers to the new
Parliament building construction
site had rammed into the cluster
bus from behind at the main traffic
light at Patel Nagar.

They said the impact left a total
of 28 people injured including the
driver of the private bus.

Banned over 22 lakh Indian accounts in June


This is higher than 19 lakh such
accounts banned by WhatsApp
in May, 16 lakh accounts in April,
and 18.05 lakh such accounts in
March. The new, tougher IT rules,
which came into effect last year,
mandate large digital platforms
(with over 50 lakh users) to pub-
lish compliance reports every
month, mentioning the details

of complaints received and
action taken.

Firms have drawn flak in the
past over hate speech, misinform-
ation and fake news circulat-
ing on their platforms. At times,
concerns have also been flagged
over digital platforms acting arbi-
trarily in pulling down content,
and 'de-platforming' users.
