# Queen Elizabeth II's first visit in 1983, show

WASHINGTON, May 26 (IANS)

NEWLY released Federal Bureau of Investigation (FBI) documents have revealed an alleged plot to assassinate the late Queen Elizabeth II while she was on a visit to the US in 1983, the media reported.

On Monday, the FBI released a 102-page cache of files, which was uploaded on the agency's information website Vault, relating to the late British monarch's travels to the US, following her death last year, reports the BBC.

The documents were published after a Freedom of Information Act request submitted by American media outlets. The assassination threat was made to a police officer in San Francisco, the files reveal.
